The selected Service Provider will work closely under the direct supervision of the Acc Lab team and work closely with the government partners. UNDP will ensure detailed monitoring and progress controls, including reporting requirement, frequency, format, and deadlines. Upon completion of each delivery, the Service Provider will provide the report on deliverables and related materials/results of work. The scope of work will be around the following essential functions:

- Prepare relevant learning materials, including module design, slides, case studies, reference assessment, course evaluation, and any other relevant documents.
- Record necessary audio and visual materials required for lecture.
- Cooperate closely with the partners to better tailor learning materials for the need of the medical personnel.
- Translate those materials into digital resources to make them compatible with the existing elearning platform.
- Create digital resources such as videos and learning modules and interactive assignments.
- Complete the technical work on the platform.

It is expected that the Service Provider will design "Mechanical ventilation and respiratory support in ICU", "Intubation techniques", "Respiratory therapy and O2 support", "Antibiotic therapy in COVID-19". The courses content should be interactive and relevant to the medical staff. It is also important that the courses will contain assignment or examination elements.

In addition to the course, it is expected that the service provider will design a simulation platform to enhance learning experience, which will include interactive medical cases on how to treat the patients with COVID-19.
